SUBJECT: Conditional Approval; RCRA Corrective Action Facility Investigation Work Plan; Former Hayes Lemmerz; Ferndale, Michigan; MID 041 803 123; Waste Data System Number 395519

The Department of Environment, Great Lakes, and Energy (EGLE), Materials Management Division (MMD), has completed its review of the Revised RCRA Corrective Action Facility Investigation Work Plan (RFI Work Plan) dated September 7, 2022, and prepared by TRC Environmental Corporation (TRC) on behalf of Detroit Axle, for the former Hayes Lemmerz property located at 1600 West 8 Mile Road, Ferndale, Michigan. The RFI Work Plan was reviewed for compliance with Part 111, Hazardous Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, and the administrative rules promulgated thereunder.

Based on our review, the RFI Work Plan is approved subject to the clarifications and conditions specified below.

- 1. **Response to Comment 2.b:** The MMD recognizes the facilities option to propose a streamlined list of analytical parameters for a given Area of Concern based on characterization data; however, it should be noted that any revision to the approved analytical parameter list requires prior EGLE review and approval.
- 2. Response to Comment 15.c: The MMD encourages the approach of developing a website to serve as a repository for all project related documents. However, it should be noted that an actual physical repository for documents must also be established to provide for members of the public who may not have access to on-line resources.
